## WATER SYSTEM EXTENSION PROJECT UPDATE - MARCH 28, 2014

A Pre-Construction conference was held on March 26, 2014. Over 30 individuals representing the Village of Jackson, the Town of Jackson, West Shore Pipe Line, PTS Contractors, Inc. and the WI DNR attended. Construction on the Water Distribution System Extension Project is scheduled to start on April 7, 2014.

PTS Contractors intend to have multiple crews working at different locations.

- Crew 1 will begin working at the Twin Creeks Road/Jackson Drive intersection and will work north to Sherman Road and then east to Hickory Lane.
- Crew 2 will begin working at the Oakland Drive/Sherman Road intersection and will work east to Maple Road then proceed south.
- Crew 3 will be working throughout the affected area on various issues such as erosion control, borings and laterals.
- An additional crew will begin working in the Crosswinds Subdivision, continuing east on Western Avenue with a bedrock grinder to install a trench.

The Contractor plans to install water main in half-mile segments (which will take a week or two on average). Once installed the section of pipe will be tested for approval. Following approval installation and connection of individual water service to homes will occur. This means that some residents could be connected to the system and begin to receive water by mid to late May. The entire project is expected to take six months.

Work Hours: PTS Contractors plans to work Monday through Thursday from 6:00 a.m. to 7:00 p.m.; work on Friday will be "as needed" to accommodate for rain delays, etc... Work in subdivisions will not commence until 7:00 a.m. The Contractor is required to accommodate traffic at all times. However, please allow the construction crews to work efficiently by avoiding construction areas as much as possible.
